Outreach Activities (2017 – 2018):

The KCEP station employed more than five but fewer than ten full-time employees during the relevant one- year period from June 1, 2017 through May 31, 2018. Thus, under the third prong of the Commission’s EEO Rule, KCEP is required to perform at least one outreach activity per year. During the 2017-2018 licenses year KCEP conducted or participated in the following outreach activities:

1. Student Internship/Teens

In keeping with the focus of its licensee, Economic Opportunity Board of Clark County, on job development and economic opportunities for minority group members, KCEP-FM has provided internship programs for local minority youth since the station was founded in 1972. The internship program is offered throughout the year, depending on schedule availability. During the 2017-2018 licenses year, KCEP hosted a total of fifteen to twenty intern students during the year from throughout the community.

Teen Talk produced by KCEP is a Public Radio Talk Show designed to give a voice to teens. The Talk Show produced by the teens focusing on the issues teens face today as well as their contributions, opinions, and achievements. The show’s target audience is 13-19 years of age with an expected adult audience who are curious and want to gain insight of teen realities. 15-20 teens every Saturday from 11 am to 3 pm. They work on show production throughout the week with our production person, Miles Farlow and is supervised by Nicky Scott and rotating students from University of Nevada Las Vegas.
